4. During the quarter, the Company raised \$83,000 from a secured convertible note issue that will be completed in the September 2012 quarter. The company proposed to raise \$760,000 and received expressions of interest for the full amount. Part of the funds will be used to retire secured convertible notes in the September quarter with the balance used for working capital.
